California’s 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. Parents were surveyed multiple times about the needs of their learners. The needs that have been identified through the surveys included the need for socioemotional support, academic intervention, and support with the learning loss created by the pandemic. When surveyed, the facilitators expressed similar concerns. All community stakeholders had the opportunity to participate in the open board meeting for the adoption of the ELO Grant Plan and the LCAP, which includes the ESSER funds.

The information that was gathered from the surveys and the formal and informal feedback sessions with parents and facilitators was used in a multitude of ways when developing the plan. When families asked for more socioemotional support, for their learners and themselves, we developed differing staff roles to respond. In addition, we invested in the ToolBox curriculum to incorporate SEL into our PBIS and to facilitate language and development of those SEL skills. When our data showed learning loss from the pandemic,

we repurposed existing staff and added new staff to add an additional adult, our Learner Support Coaches (LSC's), in the class to lower the staff to learner ratio as well as provide additional intervention during the daily schedule. The implementation of the ToolBox curriculum has been a success. Nea is using the ToolBox reflection sheets when conflicts arise. In addition the Toolbox curriculum is allowing learners to name their feelings what give them "tools" to deal with those feelings. This has help tremendously in the classroom and during recess.

With the LSC program in place to lower the ratios in the classrooms, Facilitators have been able to provide more targeted intervention during class time. The learners are working in small groups that allow for more exploration of content, support in areas that the learners are struggling in, and or opportunities for learners to work on skills.

Nea successfully facilitated one intersession camp in the fall with plans to facilitate one intersession in the winter. This allowed for Nea to target learners who were struggling with learning loss and or school engagement. Intersession also allowed for learners to stay engaged during the breaks.

The continued pandemic is still a challenge. With dealing with the implications of learners having COVID or having to quarantine from COVID exposure, some learner's attendance has been inconsistent. This affects the consistency of the interventions being provided.

A description of how the LEA is using its fiscal resources received for the 2021–22 school year in a manner that is consistent with the applicable plans and is aligned with the LEA’s 2021–22 LCAP and Annual Update.

The fiscal resources are being used in a way that aligns with the LCAP and the plans submitted previously. The funds supported and will continue to support academics, school engagement, EL learners, foster youth, and learners that were impacted by distance learning. Nea has hired extra staff to provide direct service in the classroom, a Family Learner Liaison to support families and reengage learners in school, as well as expand on the SEL curriculum through ToolBox. Nea has facilitate one intersession camp that used data to target learners who needed extra intervention as well as social emotional support. Nea will facilitate its second intersession camp during the February break.

## Introduction

California’s 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. Section 124(e) of Assembly Bill 130 requires LEAs to present an update on the Annual Update to the 2021–22 LCAP and Budget Overview for Parents on or before February 28, 2022, at a regularly scheduled meeting of the governing board or body of the LEA. At this meeting, the LEA must include all of the following:

- The Supplement to the Annual Update for the 2021–22 LCAP (2021–22 Supplement);
- All available mid-year outcome data related to metrics identified in the 2021–22 LCAP; and
- Mid-year expenditure and implementation data on all actions identified in the 2021–22 LCAP.
