Parents were surveyed multiple times about the needs of their learners. The needs that have been identified through the surveys included the need for socioemotional support, academic intervention, and support with the learning loss created by the pandemic. When surveyed, the facilitators expressed similar concerns. All community stakeholders had the opportunity to participate in the open board meeting for the adoption of the ELO Grant Plan and the LCAP, which includes the ESSER funds.

The information that was gathered from the surveys and the formal and informal feedback sessions with parents and facilitators was used in a multitude of ways when developing the plan. When families asked for more socioemotional support, for their learners and themselves, we developed differing staff roles to respond.

#### Introduction

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - o If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities
  Act, upon request; and
- Be made publicly available on the LEA's website.

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students'
    academic progress and assist educators in meeting students' academic needs, including through differentiated
    instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including
    in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;
